AMENDMENT NO. 1 TO AGREEMENT BETWEEN SANTA FE COUNTY AND WORDSWORK

This Amendment is entered into this <u>Multiple</u> day of October, 2017, by and between **Santa Fe County** (hereinafter "County"), a political subdivision of the state of New Mexico and **Wordswork** (hereinafter "Contractor").

WHEREAS, on March 31, 2014, the County and Contractor entered into Price Agreement No. 2014-0262-A-CL/MS (Price Agreement) for Contractor to provide stenography and transcription services for County meetings; and

WHEREAS, according to Article 7 (Amendment) the parties may amend the Price Agreement by an instrument in writing signed by the parties; and

WHEREAS, by a separate written Addendum to the Price Agreement dated September 16, 2015, the parties agreed that Contractor's services would be extended to providing transcription services to the Santa Fe County Sheriff's Office at the hourly rate as stated in the Price Agreement; and

WHEREAS, the parties agree to amend the Price Agreement to increase the Contractor's hourly rate from \$42.00/hour to \$50.00/hour.

NOW, THEREFORE, the parties agree to amend the Price Agreement (including the Addendum) as follows:

- 1. Attachment A referenced in the Price Agreement is deleted in its entirety and replaced with the attached revised list of meetings and Contractor's hourly rate labeled Attachment B. All references to Attachment A in the Price Agreement are to be read as references to Attachment B.
- 2. All other provisions of the Price Agreement including the Addendum, not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.

MEETINGS AND RATES FOR STENOGRAPHY AND TRANSCRIPTION SERVICES

For informational purposes, the County meetings that Contractor will be requested to provide services for are as follows, without limitation:

- The **Fire Chiefs Association** for the County Fire Department meets the 4th Thursday of the month. There are approximately 12 meetings per year. Each meeting may last up to 2 hours and the transcription time is estimated at 7 hours.
