

**SANTA FE COUNTY AMENDMENT NO. 2
TO PRICE AGREEMENT WITH BUG MASTER PEST CONTROL
FOR PEST AND RODENT CONTROL SERVICES**

This Amendment is made and entered into as of this 2nd day of October, 2017 by and between **Santa Fe County**, hereinafter referred to as "the County" and **Bug Master Pest Control**, whose principal place of business is located at 6 La Piedra Blanca, Santa Fe, N.M. 87508, hereinafter referred to as the "Contractor"

WHEREAS, pursuant to NMSA 1978, Sections 13-1-102 through 13-1-108, competitive, sealed bids were solicited through a formal Invitation for Bid, IFB #2017-0052-PW/IC, to provide pest and rodent control services for the County; and

WHEREAS, the County and Contractor entered into Agreement No. 2017-0052-PW/IC on October 25, 2016 (the Agreement) for a term of one year; and

WHEREAS, Article 7, (Amendment) of the Agreement, the Agreement may be amended by mutual agreement of the County and the Contractor. Any such amendment shall be in writing and signed by the parties; and

WHEREAS, Amendment No. 1 replaced Attachment A, adding additional buildings to be serviced by the Contractor.

WHEREAS, According to Article 4, (Term of this Agreement) of Agreement the County has the option to renew the term of the Agreement not to exceed 4 years total; and

WHEREAS, by this Amendment No. 2 the parties agree to extend the term of the Agreement from October 25, 2017 to October 25, 2018.

NOW, THEREFORE, the parties agree as follows:

1. Article 4. (Term of this Agreement) a new subparagraph "a" is inserted to read as follows:
 - a. By Amendment No. 2, the term of this Agreement is extended from October 25, 2017 to October 25, 2018 on the same terms and conditions as stated herein.
2. All other provisions of the Agreement No. 2017-0052-PW/IC not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.
