

**AMENDMENT NO. 2
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN SANTA FE COUNTY AND
NM CLERKS, LLC, TO PROVIDE ANALYTICAL AND
TECHNICAL SERVICES FOR THE SANTA FE COUNTY CLERK**

THIS AMENDMENT is made and entered into as of this 9th day of November, 2015 by and between **SANTA FE COUNTY**, hereinafter referred to as "the County", a New Mexico political subdivision, and **NM CLERKS LLC.**, hereafter referred to as "the Contractor".

WHEREAS, on December 23, 2013, the County and the Contractor entered into Professional Services Agreement No. 2014-0116-CL/IC (the "Agreement") to provide analytical and technical services regarding current election, probate, recording/e-recording, and marriage rules, regulations, legislation and case law; and

WHEREAS, the Agreement has a term of one year and by Amendment No. 1 the parties agreed to extend the term to December 23, 2015; and

WHEREAS, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, the parties wish to extend the term of the Agreement from December 23, 2015 to December 23, 2016 and increase the Contractor's compensation by \$25,000 for FY 2016; and

WHEREAS, by this Amendment No. 2 the parties agree to increase the Contractor's compensation by \$25,000 for the period of December 23, 2015 to December 23, 2016.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Article 2. (COMPENSATION, INVOICING, AND SET-OFF) of Agreement 2011-0116-CL/IC, a subparagraph "5" is inserted to read:

5) By Amendment No. 2 to this Agreement, the term of this Agreement is extended from December 23, 2015 to December 23, 2016. The total amount payable to the Contractor for the period of December 23, 2015 to December 23, 2016, exclusive of NM gross receipts tax, shall not exceed Twenty Five Thousand Dollars (\$25,000.00). The total amount payable to the Contractor under this Agreement, as amended and extended, shall not exceed One Hundred Thousand Dollars, (\$100,000.00) exclusive of NM gross receipts tax.

2. Article 3. (EFFECTIVE DATE AND TERM) of Agreement 2011-0116-CL/IC, a subparagraph "C" is inserted to read as follows:

C. By Amendment No. 2 to this Agreement, the term of this Agreement is extended for one year from December 23, 2015 to December 23, 2016, unless earlier terminated pursuant to the paragraph 5 (TERMINATION) or 6 (APPROPRIATIONS).

- All other provisions of Agreement No. 2011-0116-CL/IC not specifically amended or modified by Amendment No. 1 and this Amendment No. 2, shall remain in full force and effect.






