AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN SANTA FE COUNTY AND SUSAN B. CAVE, PhD. TO PROVIDE PSYCHOLOGICAL EVALUATIONS

WHEREAS, Article 14 (NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED) of the Agreement allows the Agreement to be amended by an instrument in writing signed by the parties; and

WHEREAS, on October 12, 2017, the parties entered into Amendment No. 1, whereby the compensation was increased from \$15,000 to \$30,000; and

WHEREAS, by this Amendment No. 2 the County wishes to extend the term of the Agreement from May 5, 2018 to May 5, 2019.

NOW THEREFORE, the parties agree as follows:

- 1. Article 3. "EFFECTIVE DATE AND TERM" is amended by adding the following sentence: By Amendment No. 2, the parties agree to extend the term of this Agreement for one year from May 5, 2018 to May 5, 2019.
- 2. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 or No. 2, shall remain in full force and effect.
