

**AMENDMENT NO. 2  
TO AGREEMENT BETWEEN SANTA FE COUNTY  
AND WASTE MANAGEMENT OF NEW MEXICO, INC.**

**THIS AMENDMENT** is made and entered into this 29<sup>th</sup> day of April 2015, by and between **SANTA FE COUNTY**, (hereinafter referred to as the "County"), and **WASTE MANAGEMENT OF NEW MEXICO, INC.**, (hereafter referred to as the "Contractor").

**WHEREAS**, pursuant to a procurement the County and Contractor entered into Agreement No. 2012-0189-CORR/TRV which provides for the Contractor to provide solid waste removal and disposal services for the Santa Fe County Adult Detention Center for a two (2) year term; and

**WHEREAS**, according to Article 15, "No Oral Modifications; Written Amendments Required," of Agreement No. 2012-0189-CORR/TRV allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

**WHEREAS**, according to Article 3 (Effective Date and Term), the County may extend the term of the Agreement for two (2) years in one (1) year increments. By Amendment No. 1 the term of the Agreement was extended to May 17, 2015. The County has notified the Contractor that the County wishes to extend the term to May 17, 2016; and


**WHEREAS**, the parties desire to enter into this Amendment No. 2 to extend the term for another year to May 17, 2016.

**NOW THEREFORE, IT IS AGREED AS FOLLOWS:**

1. ARTICLE 3. "Effective Date and Term" a new subparagraph "3.b" is inserted to read as follows:
  - b. By Amendment No. 2, the County notifies Contractor and exercises the County's option to extend the term of this Agreement for one (1) year from May 17, 2015 to May 17, 2016 on the same terms and conditions as stated in Agreement No. 2012-0189-CORR/TRV.
2. All other provisions of Agreement No. 2012-0189-CORR/TRV not specifically amended or modified by this Amendment No. 2 shall remain in full force and effect.


