AMENDMENT NO. 2 TO AGREEMENT BETWEEN SANTA FE COUNTY AND WASTE MANAGEMENT OF NEW MEXICO, INC.

THIS AMENDMENT is made and entered into this 4th day of September 2018, by and between Santa Fe County, hereinafter "County", a political subdivision of the State of New Mexico and Waste Management of New Mexico, Inc., hereafter "Contractor".

WHEREAS, on September 21, 2016, the County and Contractor entered into Agreement 2017-0029-CORR/KE (the Agreement) with a two-year term for solid waste and disposal services for the County Adult Detention Facility; and

WHEREAS, Article 4 and 16 of the Agreement allows the County to extend the term of the Agreement and to amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, Amendment No. 1 increased the compensation payable to the Contractor; and

WHEREAS, by this Amendment No. 2 the parties wish to extend the term of this Agreement for one year from September 21, 2018 to September 21, 2019 and increase the compensation by a sum of \$25,000.00.

NOW THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Article 3 (Compensation, Invoicing, and Set-Off), subpart A 2) is amended by inserting a subparagraph (a) to read:
 - (a) By Amendment No.2, the compensation payable to the Contractor for the term of this Agreement is increased by \$25,000.00. The total amount payable to the Contractor under this Agreement shall not exceed \$70,000.00, exclusive of NM grt.
- 2. Article 4 (Effective date and term), is amended by inserting a subparagraph a) to read:
 - a) By Amendment No. 2 the term of this Agreement is extended from September 21, 2018 to September 21, 2019. This term extension shall commence on September 21, 2018.
- 3. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.
