- 3. Article 3.A.2) is amended by inserting a subpart (a) to read:
 - (a) By Amendment No. 2 to this Agreement, the total amount payable to the Contractor is increased by the sum of \$18,750.00. For the term of this Agreement the total amount payable to the Contractor shall not exceed \$68,750.00, exclusive of NM grt.
- 4. Article 4 (Effective Date and Term) is amended by inserting a subparagraph b to read:
 - b. By Amendment No. 2 to this Agreement, the term of this Agreement is extended from January 8, 2020 to January 8, 2021.
- 5. All other provisions of the Agreement not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
