AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT WITH EMSRY, EMS MANAGEMENT SOLUTIONS

THIS AMENDMENT is made and entered into this day of 12018 by and between Santa Fe County (hereinafter, "County"), a political subdivision of the State of New Mexico, and EMSRX, EMS Management Solutions, whose principal address is 8160 East Buffierus, Suite 7, Scottsdale, AZ 85260 hereinafter referred to as the "Contractor."

WHEREAS, by Agreement No. 2016-0107-FD/BT (Agreement) dated January 12, 2016, the County and the Contractor entered into an agreement for Contractor to provide medical director services for the Santa Fe County Fire Department; and

WHEREAS, the term of the Agreement is due to expire January 12, 2018 and the County wishes to benefit from Contractor's services for another year and the Contractor is willing to render such services; and

WHEREAS, according to Section 15 (No Oral Modification; Written Amendments Required), all amendments and modifications to the Agreement are required to be in writing and signed by the parties; and

WHEREAS, Amendment No. I extended the term to January 12, 2018 and increased compensation payable to the Contractor by a sum of \$26,400. Amendment No. 2 extended the term to January 12, 2019 and increased compensation payable to the Contractor by a sum of \$26,400; and

WHEREAS, by this Amendment No. 3, the County wishes to extend the term of the Agreement from January 12, 2019 to January 12, 2020 and increase the compensation payable to the Contractor by \$26,400.00 for a not to exceed amount of \$105,600.00, exclusive of NM GRT.

NOW THEREFORE in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

- Section 3 (Compensation, Invoicing and Set-Off), subparagraph A.2. a subparagraph c is inserted to read:
 - c. By Amendment No. 3 to this Agreement, the compensation payable to the Contractor for the term of January 12, 2019 to January 12, 2020 shall not exceed \$26,400.00, exclusive of NM GRT. The total amount payable to the Contractor for the term of this Agreement shall not exceed \$105,600,00, exclusive of NM GRT.

- 2. Section 4 (Effective Date and Term) is unended by inserting a subparagraph c to read:
 - c. By Amendment No. 3 to this Agreement, the term of this Agreement is extended from January 12, 2019 to January 12, 2020. This term extension shall commence
- on January 12, 2019.

 3. All other provisions of this Agreement not specifically amended or modified by Amendment Nos. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
