AMENDMENT NO. 1 BETWEEN SANTA FE COUNTY AND MONTGOMERY AND ANDREWS, P.A. TO PROVIDE LEGAL SERVICES

This Amendment is made and entered into as of this 3/5t day of Mack, 2015 by and between **Santa Fe County**, hereinafter referred to as "the County", a New Mexico political subdivision, and **Montgomery and Andrews**, **P.A.**, hereafter referred to as "the Contractor".

WHEREAS, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-153 of the Procurement Code, a Request for Proposals was issued for a multiple source award for legal services and completed through RFP No. 2013-0170-LG/PL; and

WHEREAS, the County and Contractor entered into Agreement No. 2013-0170-LG/PL-E on April 30, 2013 for these services for a term of two years from April 1, 2013 to March 31, 2015; and

WHEREAS, Section 18, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED" of Agreement No. 2013-0170-LG/PL-E allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, Section 3, "EFFECTIVE DATE AND TERM" of Agreement No. 2013-0170-LG/PL-E the County has the option to renew the Agreement on the same terms and conditions for one year; and

WHEREAS, by Amendment No. 1 the parties agree to renew the term of Agreement No. 2013-0170-LG/PL-E for legal services rendered from April 1, 2015 to March 31, 2016.

NOW, THEREFORE, the parties agree as follows:

- 1. Article 3. "EFFECTIVE DATE AND TERM" a new subparagraph "3.a" is inserted to read as follows:
 - a. By Amendment No. 1, the term of this Agreement is extended for one (1) year from April 1, 2015 to March 31, 2016 on the same terms and conditions as stated herein.
- 2. All other provisions of the Agreement No. 2013-0170-LG/PL-E not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
