## AMENDMENT NO. 3 TO SANTA FE COUNTY PROFESSIONAL SERVICES AGREEMENT WITH PETER D. & COMPANY, INC. FOR DWI PREVENTION PROGRAMS

WHEREAS, on December 14, 2012 the County and Contractor entered into Agreement No. 2013-0078-A-DWI/MS for the Contractor's provision of evidence-based prevention programs to reduce underage drinking, DWI, and related risk factors among Santa Fe County youth (Media Literacy Prevention Program);

WHEREAS, by Amendment Nos. 1 and 2, the Contractor's scope of services was amended, the Contractor's compensation increased, and the term of Agreement No. 2013-0078-A-DWI/MS was extended to June 30, 2014. At this time the contract sum for the term of the Agreement is \$48,236.00 exclusive of NM grt;

WHEREAS, pursuant to Article 15 (Amendment) the Agreement may be amended by an instrument in writing executed by the parties

WHEREAS, the term of the Agreement is due to expire June 30, 2014 and the County wishes to have Contractor continue its prevention programs, increase the Contractor's compensation, and extend the term into the academic year for FY 2015.

**NOW, THEREFORE,** in consideration of the premises and mutual obligations herein, the parties mutually agree as follows:

- 1. Paragraph 1.A.B.(Scope of Work) of Agreement No. 2013-0078-A-DWI/MS the reference to "(25)" is deleted and replaced with "(20)" and the word "difference" is corrected to read "different."
- 2. Paragraph 2.A (Compensation, Invoicing and Set-Off) is amended by inserting a subparagraph "A.1)(b)" to read as follows:
  - (b) By Amendment No. 3, the County exercised its second option to renew the term of this Agreement. The compensation payable to the Contractor for the renewal period from June 30, 2014 to May 31, 2015 is twenty two thousand seven hundred sixty eight dollars (\$22,768.00), exclusive of NM gross receipts tax. The total amount payable to the Contractor for the term of this Agreement shall not exceed Seventy One Thousand Four Dollars and No Cents (\$71,004.00), exclusive of NM gross receipts tax.

- 3. Paragraph 3 (Effective Date and Term) is amended by inserting a subparagraph "B" to read as follows:
  - B. By Amendment No. 3 to this Agreement, the County exercised its second option to renew the term of this Agreement. Amendment No. 3 shall be effective upon the date first written above and the renewed term of this Agreement shall commence June 30, 2014 and terminate May 31, 2015.
- 4. All other provisions of Agreement No. 2013-0078-A-DWI/MS not amended or modified by Amendment Nos. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
