- 1. A subparagraph "3.c" be inserted in Paragraph 3 "EFFECTIVE DATE AND TERM" of MOA No. 2013-0241-CL/PL to read as follows:
  - c. By Amendment No. 3, the term of MOA No. 2013-0241-CL/PL is hereby extended for one (1) additional year from February 28, 2017 to February 28, 2018 on the same terms and conditions.
- 2. All other provisions of MOU No. 2013-0241-CL/PL, not specifically amended or modified by this Amendment No. 3, shall remain in full force and effect.
