

**AMENDMENT NO. 4
PROFESSIONAL SERVICES AGREEMENT
WITH APRYL MILLER TO PROVIDE COUNSELING SERVICES**

THIS AMENDMENT is made and entered into as of this 28th day of July, 2017 by and between **Santa Fe County**, hereinafter referred to as "the County", a New Mexico political subdivision, and **Apryl Miller**, hereafter referred to as "the Contractor".

WHEREAS, on September 4, 2014, the County and the Contractor entered into Agreement No. 2015-0006-HH/MM for the Contractor's provision of individual and/or family counseling sessions for Teen Court referred clients; and

WHEREAS, Amendment No. 1, 2 & 3, increased the Contractor's compensation and extended the term ; and

WHEREAS, Article 3 (EFFECTIVE DATE AND TERM) of the Agreement provides for a one year term and reserves to the County the option to extend the term of the Agreement for a term not to exceed two years; and

WHEREAS, Article 15, (NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED), of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties

WHEREAS, by this Amendment No. 4 the parties agree to extend the term of the Agreement from September 4, 2017 to September 4, 2018 and increase compensation by \$13,000.

NOW, THEREFORE, the parties agree as follows:

1. Article 2.A.2) is amended by inserting a subparagraph "b" to read:
 - b. By Amendment No. 4, the compensation payable to the Contractor is increased by \$13,000.00. The total amount payable to the Contractor under this Agreement shall not exceed \$51,000.00 exclusive of NM grt.
2. Article 3. "EFFECTIVE DATE AND TERM" is amended by inserting a subparagraph "C" is inserted to read as follows:
 - C. By Amendment No. 4, the term of this Agreement is extended for one year. Such term shall commence on September 4, 2017 and shall terminate September 4, 2018.
3. All other provisions of the Agreement No. 2015-0006-HH/MM not specifically amended or modified by Amendment Nos. 1, 2, 3 and this Amendment No. 4, shall remain in full force and effect.
