AMENDMENT NO. 4 TO AGREEMENT BETWEEN SANTA FE COUNTY AND MONTGOMERY AND ANDREWS, P.A.

THIS AMENDMENT is made and entered into this 24th day of 2016 between Santa Fe County, hereinafter referred to as the "County," and Montgomery and Andrews, P.A., hereafter referred to as the "Contractor."

WHEREAS, the County and Contractor entered into Agreement No. 2013-0170-LG/PL-E (the Agreement) on April 30, 2013, for Contractor to provide legal services for an initial term of two years; and

WHEREAS, by Amendment No. 1 dated March 31, 2015, the term of the Agreement was extended to March 31, 2016; and

WHEREAS, by Amendment Nos. 2 and 3, the Agreement was amended to increase the Contractor's compensation; and

WHEREAS, according to Section 8 of the Agreement (No Oral Modifications; Written Amendments Required), the parties may amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, pursuant to Section 3 (Effective Date and Term) of the Agreement, the County requests that the Contractor continue to provide legal services on the same terms and conditions as stated the Agreement.

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties mutually agree as follows:

- 1. Article 3 (Effective Date and Term) is amended by inserting a subparagraph "b" to read:
 - b. By Amendment No. 4, the term of this Agreement is extended for one year from April 1, 2016, to March 31, 2017, on the same terms and conditions as stated herein, unless earlier terminated pursuant to Section 5 (Termination) or Section 12 (Appropriations and Authorizations), of this Agreement.
- 2. All other provisions of the Agreement not specifically modified or amended by Amendment Nos. 1, 2, 3 and this Amendment No. 4 shall remain in full force and effect.
