2. Description of Modification:

WHEREAS, on February 12, 2013, the Owner and Engineer entered into Agreement No. 2013-0014-PW/MS (the Agreement) to provide for the Engineer's completion of the Northeast and Southeast Connector Alignment and Corridor Study for contract a sum of \$388,214.91, exclusive of NM grt; and

WHEREAS, Amendment No. 1 to the Agreement amended the time period stated in Exhibit A, part A.3.01 of the Agreement to extend the time period during which the Engineer is required to render services from 12 months to 18 months; and

WHEREAS, Amendment No. 2 to the Agreement again increased the time period for rendering services by extending it an additional 7 months and increased the Engineer's compensation by \$31,550.30; and

WHEREAS, Amendment No. 3 to the Agreement again increased the time period for rendering services by extending it an additional 6 months, amended the Engineer's basic services, and increased the Engineer's compensation by \$33,392.82 for a total contract sum of \$453,158.03; and

WHEREAS, the parties have been extending the time period for the Engineer to render and complete services under the Agreement pursuant to the provisions in Exhibit A, part A.3.01 (*Times for Rendering Services*) of the Agreement based on an apparent ambiguity in Exhibit A, part A.3.01; and

WHEREAS, pursuant to Article 3 (Times for Rendering Services) and Article 6.02 (Total Agreement) of the Agreement, the Owner wishes to increase the compensation payable to the Engineer in the amount of \$21,620.55 to allow the Engineer and its sub-consultants to complete Phase C of the project; extend the time period in which the Engineer shall perform and completed services under the

Agreement; and amend part A.3.01 to clarify the time period in which Engineer shall perform services and complete the deliverables under the Agreement.

Now therefore, Agreement No. 2013-0014-PW/MS is amended as follows:

a. Exhibit A, part A.3.01 *Times for Rendering Services* is amended by deleting it in its entirety and replace with the following:

A.3.01 Time for Rendering Services

A. Engineer's services under this Agreement shall be performed and all deliverables completed and delivered to the Owner no later than February 12, 2017.
