

**AMENDMENT NO. 4 TO
AGREEMENT BETWEEN SANTA FE COUNTY
AND PERKINS COIE, LLP**

THIS AMENDMENT is made and entered into this 28th day of July, 2017, between **Santa Fe County**, hereinafter referred to as the "County," and **Perkins Coie, LLP**, with its principal place of business at 700 13th Street, NW, Suite 600, Washington, DC 20005-3960, hereinafter referred to as the "Contractor."

WHEREAS, the County and Contractor entered into Agreement No. 2015-0349-LD/MY (the Agreement) on July 29, 2015, for Contractor to provide legal services for an initial term of one year; and

WHEREAS, by Amendment No. 1 the Agreement was amended to extend the term to July 29, 2017, and increased the compensation payable to the Contractor; and

WHEREAS, by Amendment No. 2 the Agreement was amended to increase the compensation payable to the Contractor; and

WHEREAS, by Amendment No. 3, the Agreement was amended to increase the compensation payable to the Contractor; and

WHEREAS, according to Article 14 of the Agreement (No Oral Modifications; Written Amendments Required), the parties may amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, the County wishes to amend the Agreement to provide for an increase in compensation payable to the Contractor by \$40,000.00 and extend the term to July 29, 2018.

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties mutually agree as follows:

1. Article 2 (Compensation and Invoicing) is amended by inserting the following as subparagraph L:

L. By Amendment No. 4 to this Agreement, the compensation payable to the Contractor for the term of this Agreement through July 29, 2018, is increased by \$40,000.00. The total compensation to be paid under this Agreement, including fees and costs, shall not exceed \$321,000.00, exclusive of New Mexico gross receipts tax. Any such taxes levied on the amounts payable under this Agreement shall be paid by the County to the Contractor.

2. Article 3 (Effective Date and Term) is amended by inserting the following as subparagraph B:

B. By Amendment No. 4 the term of this Agreement is extended from July 29, 2017 to July 29, 2018, on the same terms and conditions as stated herein,

unless earlier terminated pursuant to Article 5 (Termination) or Article 6 (Appropriations and Authorizations).

3. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3 and this Amendment No. 4 shall remain in full force and effect.




