

**AMENDMENT NO. 4  
TO PROFESSIONAL SERVICES AGREEMENT BETWEEN  
SANTA FE COUNTY AND  
CHRISTUS ST. VINCENT REGIONAL MEDICAL CENTER**

This Amendment is made and entered into as of this 1<sup>st</sup> day of Nov, 2015, by and between Santa Fe County, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and CHRISTUS St. Vincent Regional Medical Center, (hereinafter referred to as "Contractor").

**WHEREAS**, on November 8, 2011 the County and the Contractor entered into Agreement No. 2012-0052-DWI/TRV (Agreement) in the amount of \$300,000.00 for the Contractor to provide detoxification services; and

**WHEREAS**, by Amendment No. 1 dated August 1, 2012, the Agreement was amended to extend the term of the Agreement for one year to November 8, 2013 and increase the total compensation by \$300,000.00 for a total contract sum of \$600,000.00; and

**WHEREAS**, by Amendment No. 2 dated August 27, 2013, the Agreement was amended to extend the term of the Agreement for one year to November 8, 2014 and increase the total compensation by \$300,000.00 for a total contract sum of \$900,000.00 and;

**WHEREAS**, by Amendment No. 3 dated December 8, 2014, the Agreement was amended to extend the term of the Agreement for a year four through November 8, 2015; increase the total compensation by \$300,000.00 for a total contract sum of \$1,200,000.00; change the scope of work to allow CHRISTUS St. Vincent, Care Connection the use of a Santa Fe County Vehicle; and allow the County the use of office space at the Contractor's facility; and

**WHEREAS**, according to Paragraph 3 (Effective Date and Term) of the Agreement the County may extend the term of the Agreement in one year increments for a total term of four years; and

**WHEREAS**, according to Paragraph 15 (No Oral Modifications; Written Amendments Required) of the Agreement the parties may amend the Agreement by and instrument in writing executed by the parties; and

**WHEREAS**, the term of the Agreement is due to expire on November 8, 2015, a re-bid or solicitation for these services is pending but not yet completed, and Contractor's services are needed until the solicitation for the continuation of these important services is completed; and

**WHEREAS**, the parties wish to increase the Contractor's compensation by \$25,000.00 and extend the term of the Agreement for 60 days until January 9, 2016, when the procurement of these services will be completed and the community can continue to receive the benefits of an alcohol and drug detoxification facility thereby reducing the burden on law enforcement and on hospital emergency services.

**IT IS AGREED AS FOLLOWS:**

1. Article 2 (Compensation, Invoicing, and Set-Off) of the Agreement is amended by deleting subparagraph 2 and replace it with:

2) The amount payable to the Contractor under this Agreement as amended by Amendment No. 4 shall not exceed Twenty-Five Thousand Dollars (\$25,000.00) for the period of November 9, 2015 to January 9, 2016, exclusive of NM grt. In no event shall the total compensation paid to the Contractor by the County exceed One Million Two Hundred Twenty-Five Thousand Dollars (\$1,225,000.00), exclusive of NM grt.


2. Article 3 (Effective Date and Term) of the Agreement is amended by adding a new subparagraph (d) to read:

(d) Pursuant to this Amendment No. 4, the parties agree to extend the term of this Agreement for 60 days from November 9, 2015 to January 9, 2016.

3. All other provisions of Agreement No. 2012-0052-DWI/TRV not specifically amended or modified by Amendment Nos. 1, 2, 3, and this Amendment No. 4 shall remain in full force and effect.




