

**AMENDMENT NO. 6 TO  
PROFESSIONAL SERVICES AGREEMENT WITH  
MILLER ENGINEERING CONSULTANTS, INC.  
TO PROVIDE CIVIL ENGINEERING SERVICES**

**THIS AMENDMENT** is entered into on this 15<sup>th</sup> day of November, 2015 by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter "Owner"), and **Miller Engineering Consultants, Inc.** whose business address is 3500 Comanche NE, Building F, Albuquerque, New Mexico 87107 (hereinafter "Contractor").

**WHEREAS**, Owner and Contractor entered into Agreement No. 2014-0105-PW/MS dated October 11, 2013 (the Agreement) to provide for Contractor's provision of civil engineering services for County Road 55-A (General Goodwin Road); and

**WHEREAS**, by Amendment Nos. 1, 2, 3 and 5, the Agreement was amended to, *inter alia*, update the Drainage Study, provide for Hec-Ras Modeling, evaluate designs, develop construction cost estimates and a decision matrix, conduct a study and report phase to evaluate storm water diversion alternatives, and prepare construction documents. The contract sum of the Agreement is a not-to-exceed amount of \$158,860.36, exclusive of NMGRT; and

**WHEREAS**, by Amendment no. 4 the term of the Agreement was extended to October 11, 2015, and the parties wish to extend the term one year to October 11, 2016; and

**WHEREAS**, Article 14 of Agreement No. 2014-0105-PW/MS allows the Agreement to be amended by an instrument in writing executed by the parties; and

**NOW, THEREFORE, IT IS AGREED AS FOLLOWS:**

1. Article 3 (Effective Date and Term) of the Agreement is amended by inserting the following as subparagraph "b":
  - b. By Amendment No. 6, the term of this Agreement is extended one year. This Agreement shall terminate October 11, 2016, unless earlier terminated pursuant to Section 4 (Termination) or Section 5 (Appropriations and Authorizations) of this Agreement. The effective date of this Amendment No. 6 shall be October 11, 2015.
2. All other provisions of Agreement No. 2014-0105-PW/MS not specifically amended by Amendments No. 1, 2, 3, 4, 5 and this Amendment No. 6 shall remain in full force and effect.
