

**AMENDMENT NO. 7 TO  
AGREEMENT BETWEEN SANTA FE COUNTY  
AND PERKINS COIE, LLP**

**THIS AMENDMENT** is made and entered into this 14<sup>th</sup> day of August, 2018, between **Santa Fe County**, hereinafter referred to as the "County," and **Perkins Coie, LLP**, with its principal place of business at 700 13<sup>th</sup> Street, NW, Suite 600, Washington, DC 20005-3960, hereinafter referred to as the "Contractor."

**WHEREAS**, the County and Contractor entered into Agreement No. 2015-0349-LD/MY (the Agreement) on July 29, 2015, for Contractor to provide legal services for an initial term of one year; and

**WHEREAS**, according to Article 14 of the Agreement (No Oral Modifications; Written Amendments Required), the parties may amend the Agreement by an instrument in writing executed by the parties; and

**WHEREAS**, by Amendment No. 1 the Agreement was amended to extend the term to July 29, 2017, increase the compensation; by Amendment Nos. 2 and 3 the Agreement was amended to increase the compensation; and by Amendment Nos. 4 and 5, the Agreement was amended to increase the compensation payable to the Contractor and extend the term to July 29, 2018. Amendment No 6 extended the term of the Agreement to July 29, 2019; and

**WHEREAS**, Amendment No. 4 incorrectly states the not-to-exceed sum as "\$321,000.00" when it should be "\$290,000.00" and this error was repeated in Amendment No. 5. This Amendment No. 7 will correct the errors made in Amendment Nos. 4 and 5.

**NOW THEREFORE**, the Agreement is amended to correct the error as follows:

1. Article 2 (Compensation and Invoicing) is amended by deleting the sum "\$351,000.00" and replace it with "\$320,000.00."
2. All other provisions of the Agreement not specifically amended or modified by Amendment Nos. 1, 2, 3, 4, 5, 6 and this Amendment No. 7 shall remain in full force and effect.
