**SANTA FE COUNTY
AMENDMENT NO. 1
TO THE MEMORANDUM OF UNDERSTANDING BETWEEN
SANTA FE COUNTY AND THE SANTA FE PUBLIC SCHOOLS**

This Amendment is made and entered into as of this 1 day of June, 2017 by and between Santa Fe County, hereinafter referred to as "the County", a New Mexico political subdivision, and the Santa Fe Public Schools hereafter referred to as the "Schools".

WHEREAS, the County and Schools entered into MOU No. 2014-0306-CORR/IC on January 9, 2015 (the Agreement) to provide quality education programs and activities for youth who are neglected, delinquent, or who risk dropping out of school that are addressed by the County and Schools in the Santa Fe County Youth Development Program (Y.D.P.); and

WHEREAS, the term of the Agreement is due to expire June 1, 2017 and the County wishes to extend the term for another two year term; and

WHEREAS, Article 10, (Amendment), of the MOU allows parties to amend the Agreement by an instrument in writing executed by both parties; and

WHEREAS, by this Amendment No. 1, the County wishes to extend the term of the MOU from June 1, 2017 to June 31, 2019.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties hereto mutually agree as follows:

1. Article 2. (Effective Date and Term) a new subparagraph (a) is inserted to read as follows:
 - a) By Amendment No. 1, the term of this MOU is extended for a 2 year term from June 1, 2017 to June 1, 2019, on the same terms and conditions as stated herein.
2. All other provisions of the MOU not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.


