

**AMENDMENT NO. 2
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN SANTA FE COUNTY
AND REDWOOD TOXICOLOGY LABORATORY, INC**

Mary **THIS AMENDMENT** is made and entered into this 6th day of May, 2014 by and between **SANTA FE COUNTY** (hereinafter "County"), a political subdivision of the State of New Mexico, and **REDWOOD TOXICOLOGY LABORATORY, INC.** 3650 Westwind Blvd., Santa Rosa, California 95403 (hereinafter the "Contractor"),

WHEREAS, on July 12, 2012 the County and Contractor entered into Agreement No. 2012-0207-CORR/MS to provide for the Contractor's provision of drug monitoring and testing kits and related laboratory services for the County Corrections Department, Electric Monitoring Program;

WHEREAS, according to Section 15 of Agreement No. 2012-0207-CORR/MS, all amendments and modifications to the Agreement are required to be in writing and signed by the parties;

WHEREAS, in Amendment No. 1 to Agreement 2012-0207-CORR/MS, the number and type of drug testing kits and equipment were added to the Agreement and the term was extended to July 12, 2014;

WHEREAS, the parties wish to amend Agreement #2012-0207-CORR/MS to extend the term through July 12, 2015 and to increase the Contractor's compensation to \$70,000, inclusive of GRT.

NOW THEREFORE in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Section 2 (Compensation, Invoicing and Set-Off), subparagraph A.1) is amended by inserting a subparagraph "1)(b)" to read as follows:

- (b) By Amendment No. 2, which extends the term of this Agreement from July 12, 2014 to July 12, 2015, for this period the County shall pay to the Contractor for goods and services satisfactorily performed a sum not to exceed **Seventy Thousand and No Cents (\$70,000)**, inclusive of GRT.

2. Section 3 (Effective Date and Term) is amended by inserting a subparagraph "b" to read as follows:

- b) By Amendment No. 1 to this Agreement, the County exercised its second option to extend the term of this Agreement. By this Amendment No. 2, the term of this Agreement is extended from July 12, 2014 to July 12, 2015.

4. All other provisions of Agreement No. 2012-0207-CORR/MS not specifically amended or modified by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.
