CHANGE ORDER JUSTIFICATION (Provide definitive reason for proposed change order.)

The County requests Change Order No. 5 in the amount of \$9,987.50 for Bid Item *Unclassified Excavation*. This Change Order is necessary to account for the overage of 1,175 CY of *Unclassified Excavation*. The final Earth Volume report completed by Wayjohn Surveying determined KIMO Constructors excavated an extra 2,710 CY of material over the estimated, bid quantity. The survey was unable to take into account material moved under Bid Items *Fine Grading* or *Debris Removal*. The County project manager negotiated with KIMO Constructors to lower the quantity and price to 1,175 CY and \$9,987.50. The County believes this to be a fair and equitable adjustment.

The Contractor is directed to make the following changes in this contract:

Increase the Bid Item *Unclassified Excavation* quantity by 1,175 CY for a total of 8,345 CY and the amount by \$9,987.50 to a total of \$70,932.50.
