PR036a - Additional 911 Telephone - This proposal request pricing is fair and reasonable for the change in scope requested by the Fire Department for an additional 911 phone on the property (at the rear door to the station).

PR037 - Water Hammer Arrestors - This proposal request pricing is fair and reasonable for the addition of water hammer arrestors to the scope of work.

PR038 - Combustion Air - This proposal request pricing is fair and reasonable for the modifications in the mechanical room for combustion air (unforeseen).

PR041 - Marquee Sign Wiring - This proposal request pricing is fair and reasonable for the change in scope to add wiring to the marquee sign (also an add to the project).

PR042 - Culvert at Sidewalk - This proposal request pricing is fair and reasonable for the addition of a culvert at a sidewalk and modification of downspouts to accommodate on-site drainage conditions.

PR 043 - Carpet Backing - This proposal request pricing is fair and reasonable for the deletion of specified carpet backing (due to sub-contractor failure to order the specified backing).

PR044 - Graffiti Coating Credit - This proposal request pricing credit is fair and reasonable for the owner-requested change in scope to remove graffiti coating from the project.

PR045 - Annunciator Panel for Generator - This proposal request pricing is fair and reasonable for the addition of an annunciator panel for the generator to the scope of work (as requested by the Fire dept.)

PR046 - Video Camera Added Functionality - This proposal request pricing is fair and reasonable for the added functionality for the Video Camera/Monitor as requested by the Fire Department.

PR047 - Upgrade Strike - This proposal request pricing is fair and reasonable for the upgrade of an electric strike which was required because the strike the contractor ordered did not work with the door jamb (unforeseen).

PR048 - Water Softener Power - This proposal request pricing is fair and reasonable for work required by the contractor to hardwire the water softener.

PR049 - Bird Spike Credit - This proposal request pricing is fair and reasonable for the owner-requested change in scope to remove bird spikes from the project.

Weather and gas line delays - Days for weather (5 days) including muddy conditions which resulted in delay of pouring asphalt and days for the delay in the gas company hooking up the gas line (4 days).
