

**SANTA FE COUNTY  
AMENDMENT NO. 1 TO THE AGREEMENT  
WITH LORN TRYK ARCHITECTS, P.C.  
FOR PROFESSIONAL ARCHITECTURAL SERVICES**

**THIS AMENDMENT** is made and entered into this 9<sup>th</sup> day of December 2014, by and between **Santa Fe County**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **Lorn Tryk Architects, P.C.**, hereafter referred to as “the Contractor.”

**WHEREAS**, in accordance with Section 13-1-112 NMSA 1978, the County issued Request for Proposals (RFP) No. 2014-0131-PW/PL for on-call architectural services;

**WHEREAS**, on December 10, 2013 the County and Contractor entered into Agreement No. 2014-0131-B-PW/PL to provide these services for a term of one (1) year;

**WHEREAS**, Part B, Article 12, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of Agreement No. 2014-0131-B-PW/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

**WHEREAS**, the parties desire to enter into this Amendment No. 1 to extend the term for another year to December 10, 2015.

**NOW THEREFORE**, both parties agree as follows:

1. ARTICLE 2. “EFFECTIVE DATE AND TERM” a new subparagraph “2.a” is inserted to read as follow:
  - a. By Amendment No. 1, the County notifies Contractor and exercises the County’s option to extend the term of this Agreement for one (1) year from December 10, 2014 to December 10, 2015 on the same terms and conditions as stated in Agreement No. 2014-0131-B-PW/PL.
2. All other provisions of Agreement No. 2014-0131-B-PW/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.


