AMENDMENT NO. 1 HAPPY ROOF PROGRAM HOUSING ASSISTANCE GRANT AFFORDABILTY AGREEMENT BETWEEN SANTA FE COUNTY AND QUALIFYING GRANTEE

This Amendment is made and entered into as of this 27 day of September 20 19 by and between Santa Fe County, hereinafter referred to as "the County", a New Mexico political subdivision and Edward Johannes, ("Borrower"), hereafter referred to as ("Qualifying Grantee").

WHEREAS, Qualifying Grantee, and owner in fee simple of real property located in the County of Santa Fe has applied for and has been qualified for a Housing Assistance Grant from the Santa Fe County Housing Assistance Happy Roofs Program; and

WHEREAS, the Vendor selected to complete the project, Habitat for Humanity, provided a proposal for the roof repair project in the amount of \$12,100.00; and

WHEREAS, on July 14, 2019, the County and Qualifying Grantee entered into Agreement No. 2020-0006-GM/TR for this program for a term of ten years; and

WHEREAS, Section 6, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED" of Agreement No. 2020-0006-GM/TR allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, the cost of the roof repair has increased by \$500.00, because the initial write up did not include unforeseen damage to the plywood roof decking on the upper roof; and

WHEREAS, by this Amendment No. 1 the parties agree to amend Agreement No. 2020-0006-GM/TR to increase the grant sum by \$500.00 to \$12,600.00 due to the increase in the cost for the repair.

NOW, THEREFORE, the parties agree as follows:

- 1. Article 1. "SCOPE OF AGREEMENT" in paragraph A, "\$12,100.00" is deleted and replaced with "\$12,600.00."
- 2. Article 2. "HOUSING ASSISTANCE GRANT", the references to "\$12,100.00" are deleted and replaced with "\$12,600.00."
- 3. All other provisions of the Agreement NO. 2020-0006-GM/TR not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
