

**SANTA FE COUNTY
AMENDMENT NO. 4
TO THE AGREEMENT WITH LA FAMILIA MEDICAL CENTER FOR
THE DELIVERY OF MEDICATION ASSISTED TREATMENT SERVICES**

THIS AMENDMENT is made and entered into this 22 day of January 2016, by and between **Santa Fe County**, (hereinafter referred to as "County") and **La Familia Medical Center**, (hereinafter referred to as "Contractor").

WHEREAS, the County and Contractor entered into Agreement No. 2014-0035-HHS/PL on September 12, 2013, to provide for the Contractor's delivery of medication assisted treatment services and outreach programs; and

WHEREAS, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties; and

WHEREAS, by Amendment No. 1 dated June 6, 2014, the Agreement was amended to allow the Contractor to expand its public awareness/outreach campaign efforts and the Contractor's compensation was increased by \$13,000; and

WHEREAS, by Amendment No. 2 dated August 4, 2014, the County extended the term of the Agreement to September 12, 2015, and increased the Contractor's compensation by \$50,000 for a total not-to-exceed amount of \$158,000; and

WHEREAS, by Amendment No. 3 dated August 6, 2015, the County extended the term of the Agreement to September 12, 2016; and

WHEREAS, by this Amendment No. 4 the County wishes to increase the amount of funding under the contract by \$50,000, which will continue to cover staffing costs for the services; and

WHEREAS, both parties desire to enter into this Amendment No. 4.


NOW, THEREFORE, it is mutually agreed between the parties that Agreement No. 2014-0035-HHS/PL be amended as follows:

1. ARTICLE 2.A.3). (Compensation, Invoicing and Set-Off) is amended by inserting subparagraph "c" to read as follows:
 - c. Pursuant to Amendment No. 4, the Contractor's compensation is increased by fifty thousand dollars (\$50,000.00). The total amount payable to the Contractor for the term of this Agreement, inclusive of gross receipts tax, shall not exceed Two Hundred Eight Thousand Dollars (\$208,000.00).

2. All other provisions of Agreement No. 2014-0035-HHS/PL not specifically amended or modified by this Amendment No. 4 shall remain in full force and effect.






