State and Local Government Master Lease Purchase Agreement

### SCHEDULE

The Sharp Electronics Corporation (Lessor) and Santa Fe County (Lessee) are parties to the State and Local Public Bodies Agreement identified by the Master Lease Agreement specified above (the Master Lease Agreement). This Schedule No. 3091 and the Master Lease Agreement comprise a separate Lease between the parties. The terms and conditions of the Master Lease Agreement are hereby incorporated by reference into this Schedule. All capitalized terms used in this Schedule without definition have the meaning ascribed to them in the Master Lease Agreement. As with the Master Lease Agreement, Lessor and Lessee agree that any Lease entered into under the provisions of the Schedule is a "True Lease" with an option to purchase equipment at fair market value and is not an installment or finance lease agreement.

1. Lease.

- a. Description of Leased Equipment: MX3070N (main frame), MXFN27 (inner finisher), MXDE26 (Stand with 1x500 sheet drawer), MXFX15 (Fax kit), MXPN14B (punch kit).
- b. Term: 48 months commencing from the date the equipment is installed (plus the number of days from and including the Acceptance Date and including the last of the calendar month or quarter in which the Acceptance Date occurs).
- c. Rent: \$134.72 per month, exclusive of tax. Black prints @ \$0.0069 each and color prints @ \$0.0460 each.

2. Pricing Expiration Date: 48 months from installation. Lessee's obligation to lease the Equipment is subject to the Acceptance Date being on or before pricing Expiration Date.

3. Equipment Location: Santa Fe County Public Works, 424 Hwy 599, Santa Fe, NM 87507.

4. Lessor/Seller: Sharp Electronics Corporation.

5. Additional Provisions:

- a. Lease Term commences on the date the equipment is installed.

- b. This Lease shall be interpreted and enforced according to the laws of the State of New Mexico. This Schedule represents the entire agreement between the parties and shall not be amended, altered or modified except by an instrument in writing signed by the parties.

6. Fiscal Period: (Annual) 2016 - 2017.

Lessor agrees to Lease and Lessee agrees to lease from Lessor the Equipment described in Section 1.a above. Such lease will be covered by the Master lease Agreement and this Schedule including important additional terms and conditions set forth above, if any. In the event of any conflict between the terms and conditions of this Schedule and the Master Lease Agreement the terms of the Master Lease Agreement shall govern.


