RE: Signal and Lighting Maintenance Agreements: D08946, D08947, D12757 and D13723

Dear Ms. Miller:

Santa Fe County and the New Mexico Department of Transportation have long worked together in highway reconstruction and maintenance of signals and roadway lighting. The County and the Department entered into several maintenance agreements for locations on NM 599 between NM 14 and Camino La Tierra, as identified above.

As we understand, the locations covered by these maintenance agreements have been annexed by the City of Santa Fe and the County wants to terminate these maintenance agreements.

Contracts D08946 and D08947 contain the following language in the last section entitled "The Department and Public Entity Agree," Paragraph 2: "Any alteration or revision of this Agreement must be in writing and must have the written approval of the Secretary of the State Highway & Transportation Department of New Mexico in order to be effective."

Contracts D12757 and D13723 at Section XIII entitled "Amendment" reads: "This AGREEMENT shall not be altered, modified, or amended except by an instrument in writing and executed by the parties hereto."

In addition, Contracts No. D12757 and D13723 contain pertinent language in Section XIV, "Term," which states in pertinent part: "This agreement may be terminated upon 60 days written notice by the Public Entity. The Public Entity anticipates that the property at issue with this project will be annexed by the City of Santa Fe, which will require termination of the agreement."
