- (1) The Comell student, Leigh Scudder will be sponsored by the Host for the performance of a specified work assignment. The start date is 6/1/2018 and the end date is 8/1/2018
- (2) The Host will be the supervisor of the student. The Host will direct the details, and the means by which the result is to be accomplished. The Institution's only role will be to act as "Paymaster" should the Host desire the Institution to do so and execute this Agreement, the Institution will process and pay to the student any grant/award provided by the Host.
- (3) The Host agrees that no student will be denied work or be subject to different treatment under this agreement on the basis or race, color, creed, national origin, ethnicity, sex (including pregnancy), sexual orientation, marital status, disability, age, religion, veteran, or ex-offender status as prescribed by law. The Host also agrees to comply with the provisions of the Civil Rights Act of 1964 (P.L. 88-352;78 Stat, 252) and Title IX of the Higher Education Amendments of 1972, as well as other laws, regulations and orders relating to discrimination which are applicable to the Agency.
- (4) The Host certifies that it is a responsible organization with professional (non-student) supervision and staff, and the work performed by the student(s) will be responsibly supervised and consistent with the approved job description on file with the Institution. The Host agrees to submit for review and approval any changes to the job description on file for the student.
- (5) Transportation for students to and from work will not be provided by the Host or the Institution.
- (6) This agreement shall take effect 6/1/2018 and shall terminate after 8/1/2018
- (7) The Cornell student Leigh Scudder will be registered for a graduate independent study Course GRAD 9016 at the Institution and will be covered by the Institution's student insurance during the period of this internship.
