

**SANTA FE COUNTY
AMENDMENT NO. 3 TO
PROFESSIONAL SERVICES AGREEMENT
BETWEEN SANTA FE COUNTY
AND REDWOOD TOXICOLOGY LABORATORY, INC.**

THIS AMENDMENT is made and entered into on this 25th day of June, 2015 by and between **SANTA FE COUNTY** (hereinafter referred to as the "County"), a New Mexico political subdivision, and **REDWOOD TOXICOLOGY LABORATORY, INC.**, 3650 Westwind Blvd., Santa Rosa, California 95403 (hereinafter referred to as the "Contractor").

WHEREAS, on July 12, 2012, the County and Contractor entered into Agreement No. 2012-0207-CORR/MS to provide for Contractor's provision of drug monitoring and testing kits and related laboratory services for the County Corrections Department, Electric Monitoring Program; and

WHEREAS, according to Section 15 of Agreement 2012-0207-CORR/MS, amendments must be in writing signed by the parties; and

WHEREAS, by Amendment No. 1, the term of the Agreement was extended to July 12, 2014, additional drug testing kits and laboratory services were added to the Contractor's services, and the compensation payable to the Contractor was increased by \$35,000. By Amendment No. 2, the term of the Agreement was extended to July 12, 2015 and the compensation payable to the Contractor was increased by \$70,000; and

WHEREAS, by this Amendment No. 3 the parties wish to extend the term to July 12, 2016, add an additional drug test kit to the goods and services provided by the Contractor and increase the compensation payable to the Contractor by \$35,000 for a total contract sum of \$175,000.00.

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Section 1 (Scope of Work) subpart A.1) a new subparagraph "r" is inserted to read:

r) By Amendment No. 3 to this Agreement, Contractor's goods and services to be provided under this Agreement will include an EZ Key Cup II at a unit cost of \$5.00 per cup.

2. Section 2 (Compensation, Invoicing and Set-Off), subparagraph A.1) is amended by inserting a subparagraph "1(c)" read:

(c) By Amendment No. 3, which extends the term of this Agreement from July 12, 2015 to July 12, 2016, for this period the County shall pay to the Contractor for goods and services satisfactorily performed a sum not to exceed **Thirty Five Thousand Dollars (\$35,000.00)**, inclusive of NM grt.


3. Section 3 (Effective Date and Term) is amended by inserting a subparagraph "c" to read as follows:

(c) By Amendment No. 3 to this Agreement, the County exercised its third option to extend the term of this Agreement. By Amendment No. 3, the term of this Agreement is extended from July 12, 2015 to July 12, 2016.

4. All other provisions of Agreement No. 2012-0207-CORR/MS not amended or modified by Amendments 1, 2 and this Amendment No. 3 shall remain in full force and effect.




3. Section 3 (Effective Date and Term) is amended by inserting a subparagraph "c" to read as follows:




