

**AMENDMENT NO. 1
TO AGREEMENT BETWEEN
SANTA FE COUNTY AND WASTE MANAGEMENT OF
NEW MEXICO, INC. TO PROVIDE SOLID WASTE
REMOVAL/DISPOSAL AND RECYCLABLE MATERIAL REMOVAL
SERVICES FOR THE SANTA FE COUNTY
ADULT DETENTION FACILITY**

THIS AMENDMENT NO. 1 is made and entered into as of this 23rd day of June, 2014 by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter "County"), and **Waste Management of New Mexico, Inc.**, 402 Industrial Park Loop, Rio Ranch, NM 87124, hereinafter referred to as "Contractor."

WHEREAS, pursuant to a procurement the County and Contractor entered into Agreement No. 2012-0189-CORR/TRV which provides for the Contractor to provide solid waste removal and disposal services for the Santa Fe County Adult Detention Center for a two (2) year term;

WHEREAS, according to Article 3 (Effective Date and Term), the County may extend the term of the Agreement for two (2) years in one (1) year increments. The term of the Agreement is due to expire May 17, 2014 and the County has notified the Contractor that the County wishes to extend the term to May 17, 2015;

WHEREAS, according to Articles 4 (Additional Services) and 15 (No Oral Modifications; Written Amendments Required) of the Agreement, the County may amend the Agreement to provide for additional services by the Contractor and increase the Contractor's compensation for such services;

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Article 1 (Scope of Work), paragraph "A" deleted in its entirety and replaced with the following:

A. The Contractor shall provide all labor, materials and equipment to provide solid waste removal and disposal services, and the removal of recyclable material for the Santa Fe Adult Detention Facility (SFADF) as follows:

2. Article 1 (Scope of Work), in paragraph A, new subparagraphs "9)" and "10)" are inserted to read as follows:


9) Provide one (1) 8 cu. yd. solid waste container/bin with once a week pick up at a weekly rate of \$200.00, or with twice a week pick up at a weekly rate of \$280.00, as needed.

10) Provide one (1) 8 cu. yd. recyclable material container/bin with once a week pick up at a weekly rate of \$96.00, or with twice a week pick up at a weekly rate of \$160.00, as needed.

3. Article 2 (Compensation and Invoicing), paragraph A, subparagraph 3) "EXHIBIT A" is replaced with the "EXHIBIT A" attached hereto which indicates the increased rates/cost schedule to be paid to the Contractor for services as provided in this Agreement.
4. Article 3 (Effective Date and Term), a new subparagraph "3.a" is inserted to read as follows:
 - a. By Amendment No. 1 to this Agreement, the term of this Agreement is extended one (1) year and shall expire May 17, 2015.
5. All other provisions of Agreement No. 2012-0189-CORR/TRV not specifically amended by this Amendment No. 1 shall remain in full force and effect.





SOLID WASTE REMOVAL/DISPOSAL AND RECYCLE SERVICE FEES

2	Week	Weekly rate charge (per container) to include usage of a minimum of a 30 cu. yd. open top roll-off container, removal and disposal of solid waste	Once a week	\$150.00/haul plus Plus \$40.00 per ton disposal
3	Load	Charge per load to include usage of a minimum of a 30 cu. yd. open top roll-off container, removal and disposal of solid waste for special projects as requested by Santa Fe County Adult Detention Facility	As needed	\$150.00/haul plus Plus \$40.00 per ton disposal
4	Week	Weekly rate charge (per container) to include usage of a minimum of a 8 cu. yd. trash bin, removal and disposal of solid waste	Once a week as needed	\$200.00/haul
5	Week	Twice weekly rate charge (per container) to include usage of a minimum of a 8 cu. yd. trash bin, removal and disposal of solid waste	Twice a week as needed	\$280.00/haul
6	Week	Weekly rate charge (per container) to include usage of a minimum 8 cu. yd. recycle bin, removal and transfer to recycle facility	Once a week as needed	\$96.00 haul
7	Week	Weekly rate charge (per container) to include usage of a minimum 8 cu. yd. recycle bin, removal and transfer to recycle facility	Twice a week as needed	\$160.00 haul
