

## 2021 SPECIAL CONGRESSIONAL ELECTION PROCLAMATION

Pursuant to 1-15-18.1 NMSA 1978, I, Maggie Toulouse Oliver, New Mexico Secretary of State, by virtue of the authority vested in me, do hereby issue the following proclamation:

That a vacancy exists in the Office of United States Representative, Congressional District One; which consists of Bernalillo, Sandoval, Santa Fe, Torrance, and Valencia, counties; and

That a special election be held in the State of New Mexico to fill the vacancy in the office of United States Representative, Congressional District One, on the 1st day of June, 2021;

That each qualified political party may participate in the special election, to wit: the Democratic Party of New Mexico, the Republican Party of New Mexico, the Libertarian Party of New Mexico, and the New Mexico Working Families Party; and

That the special election shall be conducted in accordance with the provisions of the Election Code and Section 1-15-18.1, NMSA 1978.

## ONE UNITED STATES REPRESENTATIVE

**District 1**: Congressional District One is composed of Bernalillo county precincts 2 through 79, 81 through 83, 86 through 92, 94 through 114, 116, 119 through 126, 130 through 199, 202 through 212, 214 through 221, 223 through 226, 232 through 234, 236, 237, 239 through 263, 265, 267 through 334, 336 through 605, and 607 through 610; Sandoval county precincts 1 through 5, 28, 29, 38, 52, 55 through 57, 64, 74, 76, 87 through 90, 102, 114, 119, and 130 through 133; Santa Fe county precincts 15, 73, 84, 115, and 125; Torrance county; and Valencia county precincts 6, 16, 22, 28, 49, 50, 56 and 60.

TO FILL UNEXPIRED TERM

Each qualified political party participating in the special election may nominate in the manner provided by the rules of the party to select a candidate to fill the vacancy in the office of United States Representative, Congressional District One. A qualified party's nominee must be certified to the Secretary of State by the state chairman of that party no later than 5:00 p.m. on the 6th day of April, 2021.

Declarations of unaffiliated candidacy and nominating petitions for the office of United States Representative, Congressional District One, shall be filed with the Secretary of State between the hours of 9:00 a.m. and 5:00 p.m. on the 6th day of April, 2021.

Declarations of intent to be a write-in candidate for the office of United States Representative, Congressional District One, shall be filed with the Secretary of State between the hours of 9:00 a.m. and 5:00 p.m. on the 6th day of April, 2021.

To participate in this election, certificates of registration shall be subscribed and sworn as required by law: Pursuant to 1-4-8, NMSA 1978, twenty-eight (28) days ahead of the election, which falls on May 4, 2021; Pursuant to 1-4-5.7, NMSA 1978, qualified electors may register to vote or update an existing certificate of voter registration at the county clerk's office, during regular business hours and days of business beginning on the twenty-eighth (28) day preceding the election, up until the Saturday immediately prior to the election, which falls on May 29, 2021.
