Facility Dress Code

Visitors are not permitted to enter the facility with the following: hats, sunglasses, cell phones, or any electronic devices. Tobacco items of any kind, matches, lighters, alcohol, controlled substances and illegal substances are prohibited on facility grounds. Keys, currency, gifts, packages of any kind, magazines, books, purses, handbags, eyeglass cases, diaper bags, strollers, games, cards, paper of any kind are also prohibited. Any device, object or substance, whether animate or inanimate, that is capable of causing injury or fear of injury is prohibited on facility grounds. All items on person are subject to search.

1. General:

- a. All visitors must be appropriately attired in accordance with this policy before entering the Santa Fe County Adult Detention Facility.
- b. When attire is deemed not in accordance with this policy by the Front Desk Receptionist/Officer, the matter shall be brought to the attention of the Shift Commander.
- c. Visitors are subject to denial of visiting privileges for that day if their attire is not in accordance with this policy.

2. Dress Code:

- a. See-through, white, or light colored clothing is prohibited.
- b. Provocative, low cut, tight fitting or exposing clothing is prohibited.
- c. Clothing must not expose cleavage, the midriff, shoulders, or any part of the breast or thighs.
- d. Shorts, tank tops, sleeveless, cut-offs, spaghetti straps, tube tops, halter-tops, leggings, spandex or spandex like pants are prohibited.
- e. Sweat clothes or athletic (warm-up) clothing is prohibited.
- f. Undergarments must be worn but not visible through outer clothing.
- g. Skirts or dresses above the knee are not acceptable. Skirts and dresses cannot have a slit above the thigh.
- h. Footwear must be worn at all times. Sandals, flip-flops, slippers and open-toe shoes are not permitted.
- i. Hats, scarves and bandanas are not prohibited.
- j. Jackets and coats are not allowed (except during inclement weather).

3. Children:

All children will be required to adhere to the adult dress code with the following exceptions:

- a. Children may wear short pants that are no shorter than above the knee.
- b. All children, including infants, must be fully clothed at all times. Infants may wear a diaper but will not be permitted to wear only a diaper.

4. Miscellaneous: (Regardless of Age)

- a. Clothing expressing profanity, derogatory statements or remarks are not allowed.
- b. Clothing which promotes drugs, alcohol or sex is prohibited.
- c. Clothing that, in the opinion of the facility staff, is promoting gangs or that has gang symbols is not allowed.
- d. Clothing worn in a baggy or sagging fashion is prohibited.

5. Any attire not cover by this policy, that is deemed inappropriate by the Front Desk Receptionist/Officer, will be brought to the attention of the Shift Commander or Major. The Shift Commander or Major may deny visiting privileges based on the inappropriate attire and shall document any such denial to the Warden.
