Dear Santa Fe County Voters,

I am writing on behalf of the Santa Fe County (County) Board of County Commissioners (Board) to provide you with information regarding the County's general obligation bond questions (Bond Questions) that will be included on your November general election ballot.

By way of general summary:

- General obligation bonds fund critical infrastructure throughout the County in the areas of roads, water and wastewater, and open space, trails and parks;
- General obligation projects are selected to benefit a broad range of community needs and are leveraged with additional County funds to ensure successful implementation; and
- Approval of the Bond Questions will <u>not</u> increase property taxes.

On August 9, 2022, the Board adopted <u>Resolution No. 2022-063</u>, which authorized the placement of three Bond Questions on the November 8, 2022, general election ballot. The three Bond Questions ask County voters if they would like to fund up to \$25 million in capital infrastructure projects in the following areas:

- 1. Roads (\$13 million);
- 2. Water and Wastewater (\$7 million); and
- 3. Open Space, Trails and Parks (\$5 million).

Please see the attached list of specific bond projects to be potentially funded if the Bond Questions pass.

The Board respectfully encourages all County residents to educate themselves about the Bond Questions and to vote on November 8, 2022.
