



TEMPORARY PUBLIC ROAD ACCESS AUTHORIZATION
PRIVATE LANDOWNERS
SI-P20-_____

1. **ISSUANCE OF AUTHORIZATION:** The Pueblo de San Ildefonso hereby issues this Temporary Public Road Access Authorization (“Authorization”) pursuant to the *Interim Road Access Authorization Act of 2018*.
2. **PURPOSE:** The purpose of this Temporary Public Road Access Authorization is to authorize the access over Pueblo lands by private landowners and their invitees to County Maintained Roads (“CMR”) **CMR 84, CMR 84A, CMR 84B, the Northern Segment of CMR 101D, CMR 84C, CMR 84D and Sandy Way** within the Pueblo de San Ildefonso lands in accordance with the terms of the April 12, 2018 Settlement Agreement between the Pueblo de San Ildefonso, Santa Fe County, and U.S. Department of Interior regarding roads and road issues.
3. **SCOPE OF AUTHORIZATION:** This Authorization grants temporary access over Pueblo Land to private landowners and their invitees who access their property from an existing identified Access Point or Common Access Point off of the following roads: **CMR 84, CMR 84A, CMR 84B, the Northern Segment of CMR 101D, CMR 84C, CMR 84D and Sandy Way**.
4. **TERM:** This Temporary Public Road Access Authorization shall be for a maximum term of five (5) years from the Settlement Agreement effective date of April 12, 2018, and shall expire either on April 12, 2023, or when the Permittee has a means of lawful access from a Bureau of Indian Affairs (BIA) road via an identified Access Point or Common Access Point, whichever occurs first.
5. **ACCESS AND LIMITATIONS:**
 - a. This Authorization does NOT authorize access to private lands over any Pueblo Land from any unauthorized roads of convenience, or from anywhere other than an identified Access Point or Common Access Point off of CMR 84, CMR 84A, CMR 84B, the Northern Segment of CMR 101D, CMR 84C, CMR 84D and Sandy Way.
 - b. This Authorization authorizes access from an identified Access Point or Common Access Point and does NOT apply if a private landowner changes their existing point of access to the identified roads during the term of this Authorization without the Pueblo’s and the County’s prior approval.
 - c. This Authorization, and the use of the identified roads as public roads, does not confer, grant or recognize any property right or property interest to any entity, private landowner, or individual.
 - d. There may be occasions where the Pueblo may temporarily close portions of the identified roads for cultural purposes. The Pueblo will provide as much advance notice as possible of such temporary closures.
 - e. The Governor is authorized to revoke a grant of temporary access to a particular landowner if the Governor determines that the private landowner has not materially complied with, or is not in material compliance with, any terms of *Interim Road Access Authorization Act of 2018*, or this Authorization; provided, however, that, prior to revoking temporary access to a particular landowner, the Governor shall provide the private landowner with written notice of non-compliance and that the private landowner shall have a reasonable opportunity to cure the non-compliance prior to temporary access being revoked.
