



## **REVOCABLE PERMIT**

**SI-P20-**

The Pueblo de San Ildefonso hereby issues this Permit to:

**Santa Fe County  
P.O. Box 276  
Santa Fe, New Mexico 87504**

hereinafter called "Permittee." Permittee includes the employees, contractors and agents of Santa Fe County, including its Public Works Department. Permittee is authorized to enter upon Pueblo lands as follows:

**County Maintained Roads known as 84, 84A, 84B and 101D (sometimes, "identified roads")**

For the purpose herein stated:

**Continued maintenance of the identified roads, at the sole expense of Permittee, within the boundaries of the Pueblo de San Ildefonso**

Party will be present for stated purpose(s) on the following date(s) and time(s):

**Access Dates: Permit will be effective on date of execution and shall expire either on April 12, 2023, or the date upon which the Rights-of-Way are formally approved/granted by the Bureau of Indian Affairs for the identified roads, whichever occurs first. In the event the Permit terminates prior to the approval of the Rights-of-Way for the identified roads, the Permit term can be extended; provided that such extensions must be requested by the Permittee and issued in writing by the Governor.**

**Vehicle Information: Permittee's vehicles and equipment**

In consideration of the above privilege, the Permittee agrees to the following:

1. Permittee shall comply with all applicable Tribal and Federal laws and regulations.
2. Permittee shall be responsible for any damage to roads, persons and property caused by, or arising from Permittee's operations or activities relating to this Permit; provided, however, that Permittee's liability to third-parties shall be subject to and limited by the New Mexico Tort Claims Act and other applicable law.

3. Permittee shall remain within designated areas for the identified roads. Road maintenance activities shall not enlarge the existing roadways or change the locations.
4. Permittee shall immediately notify the Pueblo in the event of discovery or disturbance of any cultural matter and shall not remove any cultural matter.
5. 6. Permittee acknowledges that there may be occasions where the Pueblo may temporarily close portions of the identified roads for cultural purposes. The Pueblo will provide as much advance notice to Permittee as possible of any such temporary closures.
7. The Governor is authorized to revoke this Permit if the Governor determines that the Permittee has not materially complied with or is not in material compliance with any terms of this Permit; provided, however, that, prior to revoking this Permit, the Governor shall provide the Permittee with written notice of non-compliance and that the Permittee shall have a reasonable opportunity to cure the non-compliance prior to this Permit or temporary access being revoked.
8. This Permit is not intended to modify or amend the Settlement Agreement between the Pueblo de San Ildefonso, Santa Fe County, and U.S. Department of Interior, effective April 12, 2018.
