Attached please find the Santa Fe County FY 2014 Final Budget submission for your review and approval. This budget was approved by the Santa Fe County Board of County Commissioners via Resolution 2013-56 on June 11, 2013.

Per DFA requirements, below is the requested information as noted in the "Checklist of Budget Documents" for Counties and the Fiscal Year 2013-2014 Budget Preparation & Submission Guidelines #BFB-13-01 from Ryan Gleason. Note that changes in the information below from the FY 2014 Interim Budget are highlighted in rect

- The contract for audit of the financial statements for the Fiscal Year ending June 30, 2013
 has been procured and approved by the Office of the State Auditor. The amount of this
 contract to conduct the above audit is \$98,868 plus applicable gross receipts. Adequate
 funding has been appropriated for this cost across operating funds.
- The total number of FTEs in the Final Budget is 1008.11.
- The grand total of salaries/wages budgeted is \$46,594,879. Please note that the amount in the FY 2014 Interim Budget cover letter reported for salaries/wages was incorrect. The reported amount was \$40,707,454 and the correct amount was \$45,102,807.
- The grand total of employee benefits budgeted is \$20,448,331. Please note that the amount in the FY 2014 Interim Budget cover letter reported for employee benefits was incorrect. The reported amount was \$20,137,500 and the correct amount was \$19,216,330.
- The average rate of salary increase is 1.463% which considers pay increases per eligible employees as a percentage of total funded positions. Eligible employees are nonprobationary employees on July 1, 2013.

Santa Fe County budgeted the use of \$55,266,597 in cash. Of that amount, \$19,457,180 is budgeted cash from bond proceeds for capital projects, \$8,897,236 is cash from capital outlay gross receipts tax dedicated to capital projects, \$5,832,809 is for renewal or replacement of assets such as vehicles, computers, etc. and \$3,224,605 in cash for transfers for asset renewal and replacement. In addition, \$8,740,351 is attributable to other one-time expenses such as professional contracts and large maintenance projects. The balance of the budgeted cash, \$9,114,416 is for general operating expenses across all funds. Santa Fe County historically experiences an operating budget variance of at least 5% to 10% and continues to build, rather than deplete, its fund balances despite budgeting the use of cash each year. As such, we are comfortable budgeting some use of cash for operating expenses. The amount above represents approximately 5% of Santa Fe County's recurring expenses.

The FY 2013 fourth quarter financial report (unaudited) is also attached. The report was formally approved by the Board of County Commissioners at its meeting this morning. The Resolution number is 2013-68. A signed and recorded copy of the resolution will be available later this week.

The final budget of your local government entity for Fiscal Year 2013-14, as approved by your governing body, has been examined and reviewed. We find it has been developed in accordance with applicable statutes and budgeting guidelines. Sufficient resources appear to be available to cover budgeted expenditures.

In accordance with Section 6-6-2-(E) NMSA 1978, the Local Government Division (Division) certifies the final FY 2013-14 budget. The Budget Certification Rule, 2-2.3 NMAC, requires that the FY 2012 audit should have been already submitted to the Office of the State Auditor. The Information obtained by the Division from the Office of the State Auditor's website indicates that you are in compliance with this requirement.)

Budgets approved by the Division are required to be made a part of the minutes of your governing body according to Section 6-6-5 NMSA 1978. In addition, Section 6-6-6 NMSA 1978 provides that the approved budget is binding on local officials and governing authorities. Any official or governing authority approving claims or paying warrants in excess of the approved budget or available funds will be liable for such claims and warrants allowed.

Furthermore, state statute requires all revenue sources be expended only for public purposes, and when applicable, in accordance with the Procurement Code, Chapter 13, Article 1, NMSA 1978. Use of public revenue is also governed by Article 9, Section 14 of the Constitution of the State of New Mexico, commonly referred to as the Anti-Donation Clause.

Finally, please be advised that approval by the Division is required by Section 6-6-2 (G) (H) NMSA 1978, of all transfers between funds and all budget increases.
